Executive Decrees Asserting Sovereign Authority over a Designated Territory of the Empire of Atlantium

8.1.1 Decree Creating the Province of Aurora

Whereas the Empire of Atlantium, while largely respecting the concept of the integrity of the sovereign territorial nation-state as a person in International Law, also understands that in broader historical terms, polities and the borders by which they are delimited are neither fixed nor immutable – emerging, evolving and passing away over time in response to prevailing social, economic, political, environmental and other influences and considerations, and

Whereas the Empire of Atlantium, existing as a person in International Law since its Foundation on the 3rd Day of Decimus in the Ten Thousand Five Hundredth Year of the New Era (27 November 1981), is for all intents and purposes, a primarily non-territorial global state whose Sovereignty is founded, not upon the exclusive exercise of its Authority over geographical territory, but upon the Will of its People wheresoever they reside, and

Whereas, notwithstanding its heretofore-stated largely non-territorial nature, the Empire of Atlantium has, from its earliest days, actively sought to give physical expression to its aspirations through the acquisition of a suitable geographical territory to serve as its permanent global Capital and Seat of Government, the site of its monuments and commemorative places and as the spiritual homeland of its People,

We hereby Declare and Decree that, in fulfilment of the heretofore mentioned aspirations and considerations, the geographical territory identified as Folio 252/724566 by the Department of Lands of the State of New South Wales, within the Commonwealth of Australia, having this day come under our direct personal Authority, is duly invested with full Provincial status as a Designated Territory of the Empire of Atlantium, and shall be known henceforth as the Province of Aurora.

8.1.2 Decrees Concerning the Administrative Divisions of the Province of Aurora

We hereby Declare and Decree that:

8.1.2.1

The Province of Aurora, duly constituted as a Designated Territory of the Empire of Atlantium, shall be henceforth divided into the following three administrative Districts, the boundaries of which shall be determined by the Secretariat of Geographical Names:

- The District of Hickey
- The District of Duggan
- Concordia Capital District

8.1.2.2

The Districts of Duggan and Hickey are hereby constituted as Perpetual Nature Conservancies, and shall be reserved solely for recreational activities that impose minimal environmental impacts upon them; they shall be preserved from any and all developmental activities detrimentally impacting their natural integrity.

8.1.3 Decrees Concerning the Transfer of the Capital and Seat of Government to the District of Concordia, and of the Reconstitution of the Territory of the Former Capital

We hereby Declare and Decree that:

8.1.3.1

The Capital and Seat of Government of the Empire, having resided at the Imperium Proper Territory since its transfer from the Provisional Territory on 7 Quintus 10518 (2 June 1999) is hereby transferred to Concordia Capital District.

8.1.3.2

The Imperium Proper Territory, as a former Capital and Seat of Government of the Empire, is hereby reconstituted as an exclave administrative division of Concordia Capital District, to be known henceforth as the Prefecture of Idalia.

8.1.4 Decree Creating a Vexillum for the Province of Aurora

We hereby Declare and Decree that the Province of Aurora shall have a Vexillum of State, taking the form shown hereunder, and that it shall have precedence over all other Vexilla of State - save only the Imperial State Vexillum - when flown within the borders of the Province:



The Executive Decrees heretofore listed are issued by our Imperial Majesty under the Great Sovereign Authority of the People at the Prefecture of Idalia on this 12th Day of Primus in the 10527th Year of the New Era.
